How do I book onto training courses?

You can book courses on our website www.privatehomecare.ie or contact us in the Training Department at training@privatehomecare.ie

How are courses delivered?

Our shorter courses are half days and take place online via Zoom or www.hseland.ie. All QQI courses and Patient Moving and Handling take place in the classroom.

Where do I send my assignments?

Assignments must be sent directly to CPL Institute. They will provide you with the details on how to submit. Exams and skills demonstrations are corrected by our internal trainer.

Who do I contact if I need an extension on my QQI assignment?

The CPL Institute deal with any queries about extensions for assignments. They will provide you with contact details and more information when you sign up for a course.
